#### 3. What is the purpose for which my personal data is processed?

The aim of the project is to collect and share best practices in the Baltic Sea region for oil and chemical spill response, test the effectiveness of response equipment and create an action plan to strengthen performance and training activities. Personal data will be processed in connection with the registration of participants in events, exercises and/or tests of the project and, where necessary, for the purpose of contacting them for notification purposes in relation to mentioned events/activities.

## 4. On what basis is my personal data processed?

The legal basis for the processing of personal data is public interest (scientific research and research, development and innovation activities of universities of applied sciences.

The processing of personal data in scientific research is based on the EU's General Data Protection Regulation and national Data Protection Act. Scientific research is a task in the public interest within the meaning of the Data Protection Regulation, in which scientific research in the public interest is the basis for the processing of personal data (Data Protection Act). In the Data Protection Regulation (recital 159), the concept of research also covers RDI activities.
